

APPLICATION FOR SERVICE AND MEMBERSHIP CONTRACT

The undersigned (hereinafter referred to as the Applicant), petitions Credit Bureau Systems, Inc. for membership and access to the products and services provided by Credit Bureau Systems, Inc. to its members including Public Record Bulletin Services, Mortgage Reporting Services and all other current and future services to which Members may be entitled

THE APPLICANT agrees to pay a monthly fee or an annual fee as indicated below, in addition to any products or services provided, on receipt of the statement.

- Applicant has agreed to the terms of \$20.00 monthly for Internet Access to PRB.
- Applicant has agreed to the terms of \$300.00 annually for Internet Access to PRB.
- Applicant has agreed to the terms of \$30.00 monthly for Internet Access to PRB*.
* 2 counties
- Applicant has agreed to the terms of \$39.95 monthly for Internet Access to PRB*.
* 3 or more counties
- Applicant has agreed to the terms of \$30.00 monthly for postal delivery of PRB.

THE APPLICANT agrees to keep in strict confidence information obtained from any report or the Public Record Bulletin furnished by Credit Bureau Systems, Inc. and request it for their exclusive use only and to refrain from copying the publication.

It is agreed and understood, that in consideration of the services to be provided by Credit Bureau Systems, Inc., the Applicant agrees to pay all charges in connection with the services purchased within 30 days of receipt of billing statement. In the event that such charges are not paid within thirty days, a delinquency charge equal to one and one-half (1.5%), 18% annum, will be assessed on all delinquent amounts. Further, in the event of default, Applicant agrees to pay all costs of collection, including reasonable attorney fees, collection fees, court costs, and for all other costs to which Credit Bureau Systems, Inc. may be entitled and that are allowed by law.

Credit Bureau Systems, Inc. agrees to furnish a Public Record Bulletin each week /month containing information obtained from court house documents. Credit Bureau Systems, Inc. agrees to offer mortgage reports at the request of the Applicant. Credit Bureau Systems, Inc. agrees for furnish all other services to which Members may be entitled under the Agreement and which may be introduced by Credit Bureau Systems, Inc. at some future date, such as tenant screening, employment screening, etc. to the Applicant at the then published Members prices.

It is further mutually agreed that this member contract, if accepted by Credit Bureau Systems, Inc. shall commence on _____ and continue in effect for a period of one (1) year. Upon the expiration of the one (1) year period, this agreement shall automatically renew each year unless either party gives written notification to the other party of their intent to terminate the agreement. Such notification shall be in written form and received by the other party no later than thirty (30) days prior to the expiration of this one-year agreement. Upon renewal, and in the absence of the aforescribed written notification of intent to terminate having been received at least thirty (30) days prior to the scheduled expiration, the renewal shall always be for a period of one (1) full year and may then only be terminated by written notice thirty (30) days prior to the scheduled expiration.

Credit Bureau Systems, Inc. reserve the right to terminate the Agreement immediately without notice in the event the Applicant is delinquent in payment of the charges or is guilty of violating the terms of this agreement.

IT IS FURTHER MUTUALLY AGREED that Credit Bureau Systems, Inc. and the Applicant shall each be liable to any third party claimant for its own acts of negligence with regard to the performance of its duties hereunder, and each shall indemnify and hold harmless the other for and from all third party claims arising on the account of its acts of negligence, or on account of its failure to perform any of its obligation, hereunder, and any co~lor expense, including reasonable attorney's fees, incurred by the other in connection therewith.

The Agreement and terms contained herein shall be governed by the laws of the State of Kentucky.
